LWV MEPH March Member Meeting CMAL Study and Consensus: Metropolitan Council Governance

LWV MEPH members will have a voice in updating LWV’s position on Metropolitan Council Governance by attending our March 4th Consensus meeting. A longer article about this study from CMAL (Council of Metropolitan Area Leagues) was in the February Voter. The Metropolitan Council is currently appointed by the Governor, and has metro-wide responsibilities for long-range planning, land use planning, transportation, parks and open space, wastewater and water, and housing.

The Consensus questions include whether members should be appointed or elected, term length, nominating process, qualifications, and number of members. City mayors and administrators were surveyed for their thoughts on these topics.

Please join LWV MEPH President Peggy Kvam as she leads a discussion on CMAL’s Metropolitan Council Governance study and consensus questions. This meeting replaces our regular March program. It is free and open to the public, but only LWV MEPH members may vote on the consensus questions.

Action Team Marches On...to our March Action Team Report!

A major action team goal is to help all LWV MEPH members be active participants in our democracy. To this end, we've been putting together a simple process for you, the member, to not only take your own action, but when appropriate, to call in support from other chapter members. If you see an issue developing in our community, you will be able to easily reach out to the chapter leadership who will determine if the issue is something that triggers an action alert call to the broader membership. Even if it doesn't, we will provide you with clear guidance on how to take effective action yourself.

- We'll make sure you'll know who to contact.
- We'll provide guidance for what information we need to decide next steps.
- We'll follow specific criteria to determine whether or not an official LWV MEPH Action Alert will be created. For example, is the issue:
 - o Local? (state and national issues go to the larger LWV organization)
 - o Urgent? (do we need to take action right away?)
 - o Consistent with LWV national and state positions?
- If we decide to move forward with an Action Alert, we'll handle pushing the call out to the broader membership.
- If we decide the issue isn't suited to an Action Alert, we'll explain why and what else we might do, such as sharing the information with the chapter but without a call to action, but at the very least we'll be sure you know who and how to contact someone on the issue on your own behalf as a private citizen.

The LWV MEPH board has reviewed our draft process and guidance documents (and the reviews were positive! - ed.), so we hope to get this all finished up at the next board meeting and will bring it to you at the April LWV MEPH meeting on April 13.

What is an action alert, anyway?

An action alert is an email or phone call telling you about an urgent issue, the LWV position on it, and a request to contact your elected official expressing your concern. It will include information on who to contact and suggest best ways to do so. *It's a way for you to have a powerful and positive impact on our democracy in minutes!*
